**Missing documents:** Ensure you include all supporting documents as well as critically important maximal evidence to meet all legal, up-to-date Regulations.

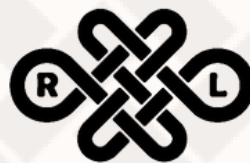
